POLITICAL PARTIES COUNCIL SETS DEADLINE FOR 2026 ELECTION REGISTRATION

JUBA (01/06/2026) — The Political Parties Council (PPC) has announced the official deadline for political parties wishing to contest in the upcoming **2026 General Elections**.

While the general registration of political parties remains an ongoing process, the PPC has established June 30, 2026, as the final cut-off date for entities aiming to participate in the 2026 elections. This directive is issued in accordance with the Political Parties Act 2012 (Amended 2022) and PPC Regulations.

The PPC strongly urges all aspiring political groups to fast-track their paperwork and submit their applications well before the June 30 deadline to avoid disqualification.

CLOSURE OF POLITICAL PARTY REGISTRATION FOR THE 2026 GENERAL ELECTIONS

PURSUANT to Sections 4, 6, 7, and 8(6)– (7) of the Political Parties Act 2012 (as Amended, 2022), and Chapter IV of the Political Parties Council Regulations 2015 (as Amended, 2024), the Political Parties Council (PPC) hereby issues this statutory NOTICE to all relevant stakeholders and the public.

TAKE NOTICE THAT:

1. The registration of political parties remains a continuous and ongoing administrative process.
2. Notwithstanding the continuous nature of registration, any entity intending to register as a political party specifically to participate in the 2026 General Elections must complete its registration on or before the absolute deadline of June 30, 2026.

The PPC hereby directs and commands all aspiring political entities to expedite the submission of their formal applications to ensure full compliance before the close of business on **June 30, 2026**.

Submission of Audited Books of Accounts by All Registered Political Parties

In accordance with Sections 21(2)(g) and 25(1)(g) of the Political Parties Act, 2012 (as Amended, 2022), and Regulation 42 of the Political Parties Council Regulations, 2015 (as Amended, 2024), the Political Parties Council (PPC) **HEREBY NOTIFIES** all registered political parties to submit their audited books of accounts for the Financial Year 2025/2026 to the PPC within the first week of July 2026.

The PPC shall subsequently publish an annual report on the audited accounts in the Official Gazette.

Required Submission Checklist:

To avoid delays, ensure your application includes:


1. Completed official registration forms.
2. Certified copy of the party constitution and rules.
3. List of founding members with nationwide membership signatures.
4. Names and addresses of national, administrative areas and states office bearers.
5. Payment receipt for the prescribed registration fees.

Action Required:

All aspiring political parties must expedite and submit their registration applications before **June 30, 2026**. Late submissions will not be eligible for the 2026 ballot.
